



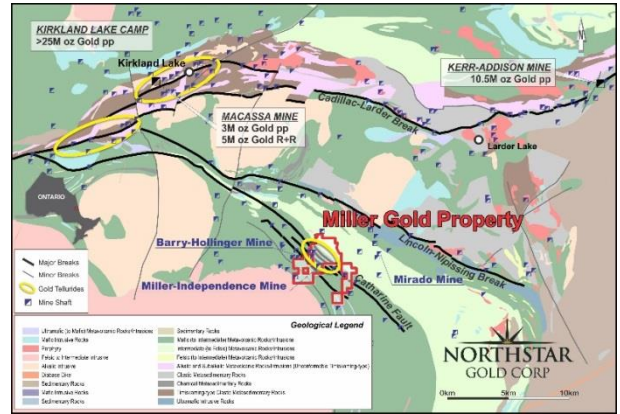

Kirkland Lake Gold Camp

The Kirkland Lake mining camp has produced > 24 million ounces of gold at an average grade of 15.4 grams of gold per tonne since 1915.

- Potential for significant near surface high-grade gold resources in multiple structurally controlled zones.

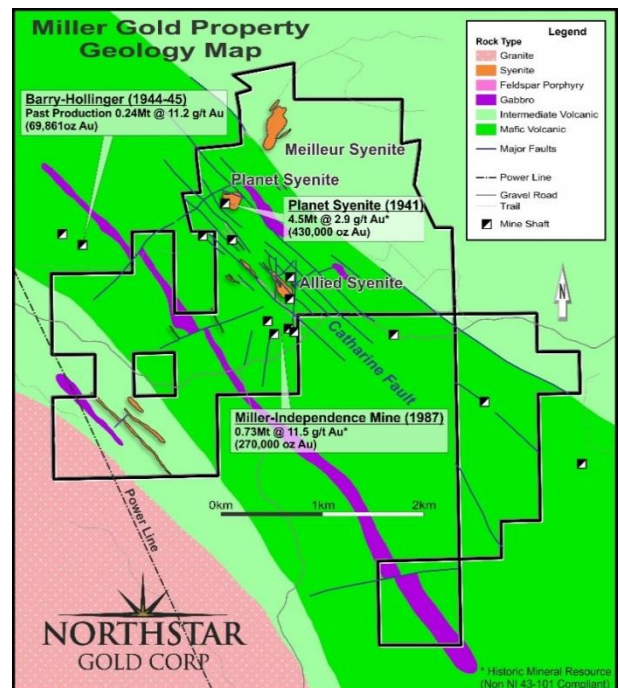
Bryce (Au) and Milestone (Cu-Ni-Co) Properties

- 100% owned 3,552 ha Bryce Intrusive Gold Property; \$4M past expenditures and multiple drill targets defined.
- 100% owned Milestone Property hosts the historic Diadem Cu-Ni-Co deposit similar to the nearby Temagami Island Copper Mine.
